RULES AND REGULATIONS

I. Rules and Regulations for the Government of Solid Waste Disposal Facilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

II. OPERATING HOURS

The normal public business hours for the landfill are:

*Monday, Tuesday, Wednesday, Thursday, Friday 8:30 a.m. to 4:00 p.m.

*Saturday 8:30 a.m. to 11:30 a.m.

FREE DAY:

Any person not in the business of hauling solid waste for hire may dispose of an amount of household solid waste equal to one (half ton) pick-up truck load, per month, free of all charges and fees.

If a "pick-up truck load" contains waste from more than a single residential household, a member of each additional household must be present with the load.

Customer must identify himself as wishing to dispose under the provisions of "Free Day", when registering at the landfill office.

"Free Day" at the Greenbrier County Landfill will be the second Tuesday of each month.

III. RULES

Greenbrier County Landfill holds a permit from the State Water Resources Board. The landfill reserves the right to refuse certain parties the use of the landfill. Reasons shall include, but are not limited to the following:

Disposal of waste which does not conform to the requirements provided in the State Water Resources Permit. We are NOT certified to accept or receive any hazardous or toxic wastes.

Any wastes held over a week's period of time;

Customers who have not paid prior past due invoices.

IV. BILLING AND COLLECTING

Charges for landfill use must be paid at the time of dumping, unless a credit agreement has been approved in advance.
